Updates from Spark Council and other Committees

Early Childhood Workforce Impact project has received funding for the child care workforce survey from the NHCF and Endowment for Health and Bureau of Child Development and Head Start Collaboration. Goal is to locate a survey vendor who will survey a sample of child care directors, teachers and other child care staff. Goal for return rate has not been set. There are other surveys going on (Market Rate, Program related data). This survey will target the workforce (wage, training, professional development, personal background, gender, ethnicity) Suggestion to include incentives. Need to sell it to directors. Will go through Child Care Aware to sell the survey. Suggestion to add question about student population. Tessa will bring that back to her committee. The group on Alternative Pathways will report out on Monday, March 26 to the leadership group. Recommendation to continue to support Running Start. Looked at national Child Development Associate certificate. Unfortunately, no college credit is attached.

There is a committee working on implementation of the **QRIS** for child care. Meeting is scheduled for March 27. Most states have tiers. NH only has two steps and then a big gap to National accreditation. Working on this for 5 years.... BCDHSC has published a draft for public comment. Funding is still an issue and will be a topic at next Tuesday's director's meeting hosted by Early Learning NH. Draft has had limited release but is online as of March.

Federal Budget Funding will increase for **CCDF budget**, it has been increased substantially with no requirement for matching funds.

Maria Doyle **NH Children's Trust** inviting proposals for trainings to communities> Looking for local partners. Host partner must guarantee 25 participants. Strengthening Families Frameworks. The training qualifies for professional development hours for early care and education professionals, as well as CEU's for Board-Certified Guardians ad Litem and Social Workers, may qualify for contact hours for nurses from related fields and satisfy the training hours requirements for other professionals. Format is usually 2 day 13-14 hours of instruction, but schedule is flexible. Maria or Julie Day are contacts

Spark NH Equity Task Force is working on a definition and set of tools to evaluate work. April 30, 9:00 to 10:30 is the next meeting All Spark committees have been asked to send a representative. Ongoing meetings of 2nd Monday of the month. Mary Ellen will attend April 30 meeting. Tessa will work to recruit a permanent member. Maria pointed out Brandeis has created a framework and assessment on culturally effective organizations. NH Health and Equity Partnership has been working on this issue and the toolkit. NHEquity.org.
