#### Summary

1. Peggy reported that the white paper is progressing
2. Kim and Peggy reported that the Endowment for Health and Charitable Foundation would like to prioritize 1-3 early childhood policy priorities for the next 5 years and create an advocacy action plan. They presented a PowerPoint which will be sent to the committee with the minutes. They recommended a longer meeting for July to narrow the policy areas to include both policy experts and content experts. Spark NH will send out a Meeting Wizard to set the date for the meeting.
3. Jeanne Agri gave an update from the CCDF task force. There are lots of new regulations from the federal government, some of which still need interpretation. There is a shift in focus now from just supporting work to really supporting families and making child care consistent for children.
4. Regional Partnerships –

- a. Safe Schools, Healthy Students – Julie reported that all three sites will be using the ASQ-SE. Concord and Laconia are using it with all children. Rochester is phasing in its use. Laconia is adding a Title I Preschool classroom. Currently they have a developmental preschool. The new class would be a 5 day preschool for 4-5 hours a day.
- b. FSP in the lakes region is using population level indicators including percentage of children receiving subsidized care in quality child care, percentage of children off schedule for the ASQ and ASQ-SE, and third grad assessment scores.
- c. Marj reported for Impact Monadnock that she is finalizing the initial “relationship building” phase of her work. She has been doing many Bedrock presentations. She is often asked what makes the initiative different and she answers, “collective impact.” They have released an RFP for a strategic planning consultant. Marj did a number of interviews with early childhood educators in the region about barriers for their children and families. Among the issues that came up were the fact that there is no early head start, that not enough children are receiving early supports and services or child care scholarships, that a lot of children are in unlicensed care. Addiction and transportation issues were also identified. Marj will now be doing similar interviews with parents. They are planning a business forum in the region for the fall.
